III Old Business

Golf Tournament

V Financial Reports

August 2024 Financial Statements Statement

Melody Higdon presented the August 2024 financial statements and review expenses over budget. Melody reported that the expense are down. Collecting golf fees upfront has cover expense spent on the golf tournament. Benevolence-Activities is under budgeted by \$ 800 due to golf fees and hole sponsors. Dues and subscriptions is over budgeted by \$ 3,063 because the HBPA dues are budgeted in September but was paid in August in the amount of \$ 3,000.
